# Level 4 Award in the Internal Quality Assurance of Assessment Processes and Practice

A practical based qualification for those who are involved in Internal Quality Assurance (IQA) in the work environment. Learners will come away with an understanding of the functions, principles, and management of IQA and the roles and responsibilities they hold within IQA processes.

## Course Content

This qualification is made up of two units: Understanding the Principles and Practices of Internally Assuring the Quality of an Assessment (L4-IQA-01 T/601/5320) and Internally Assure the Quality of an Assessment (L4-IQA-02 A/601/5321). If you have already have the Level 4 Award in Understanding the Internal Quality Assurance of Assessment Processes and Practice, or have relevant professional experience, you may be able to achieve this award by only studying unit L4-IQA-02 A/601/5321.

- Planning IQA of assessments
- Techniques and criteria for monitoring the quality of assessments
- Management of IQA information
- Legal and good practice for IQA of assessments

- Evaluating the quality of assessments

This course is delivered virtually. You will attend an induction session and two workshops, have regular 1:1s with a dedicated IQA Assessor, and have observed practice in giving feedback to others.

Learners will need access to assessors to quality assure, that they can work with over a period of time in order to evidence the IQA cycle.

6-9 months

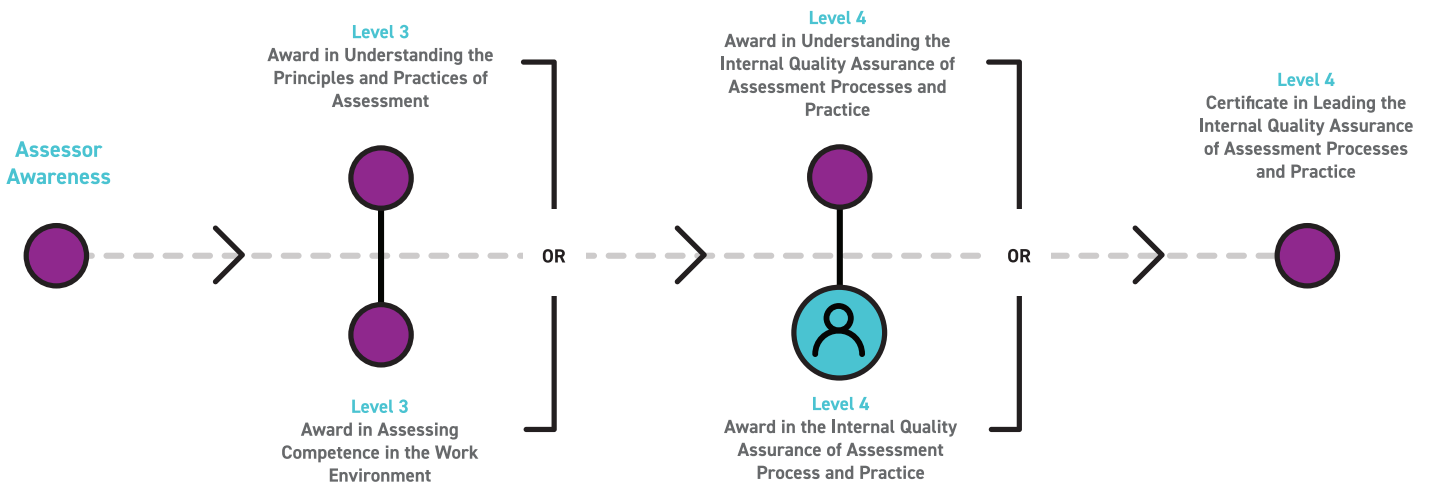
## Who this training is for
